Thank you for the email and information.

We note the contents of your email with disappointment, particularly considering our flexibility with the agreed terms, especially timelines, throughout the project duration, contrasted with Market Kinetics consistent failure to fulfil their commitments as per those timelines. This further delay poses significant financial implications for us, compounding our challenges, as we have proceeded with financial commitments based on the expectation that the promised refund would be executed by March 15, 2024.

It's important to acknowledge that an employee's commitment/statements retain their significance and accountability, irrespective of any inadvertent inaccuracies.

While we appreciate the suggestion to expedite the payment, we find it reasonable to request an immediate partial refund, with the balance to be settled by June. Hence, we request that at least 50% of the refund be processed without delay, with the remaining 50% disbursed by the agreed-upon date of June 15, 2024.

Provided below are the banking details for the prompt wire transfer of the initial sum. We anticipate a swift and amicable resolution to this matter and appreciate your cooperation and understanding.

Market Kinetics is under new management and ownership as of March 1, 2024. Mr. Courtney Olujobi is no longer with the company and Mr. Shirona A Gunawardhana is in a limited advisory role during the transition. We are expecting the transition to take 60 to 90 days.

We noticed that there is a request for a refund of US\$ 61,000 (sixty one thousand) filed on January 6, 2024. According to the agreement you signed with Market Kinetics the refunds are issued within 180 (one hundred and eighty) days.

Mr. Olujobi by a mistake has provided you a refund by date of March 15, 2024. Per the agreement, the due date should be July 5, 2024. Mr. Gunawardhana however has advised us to expedite the payment. The management has agreed to initiate the refund of US\$ 61,000 (sixty one thousand) by June 15, 2024.

Please provide us the banking information to wire the US\$ 61,000 (sixty one thousand). Our sincere apologies for the miscommunication.

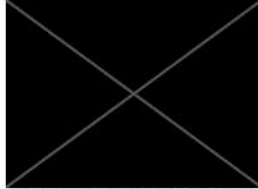
